

- Minimising the footprint of our Projects by undertaking a calculation of the total carbon account for all our new Projects (including construction and operational carbon emissions) in accordance with the Climate Active Carbon Neutral Standard.
- Proactively working with waste contractors to recycle at least 90% of all demolition and construction waste
- Seeking to purchase products that are highly recyclable and contain recycled content
- Proactively seeking partners that align with our values and commitment to create the better future we all deserve, and actively communicate the value of our position to those who don't
- Undertaking as-built monitoring to test the sustainability outcomes of our Projects, reporting on outcomes to key stakeholders
- Complying with all legislative requirements
- Ensuring management are committed to the effective Implementation of ISO 14001 including allocation of adequate
- Reviewing our processes and aligning the way we work with ISO 14001 - Environmental Management
